Last Will & Testament



This is our most basic plan

It includes a Last Will and Testament, Power of Attorney for Financial Decisions, and Health Care Power of Attorney ("Living Will")

This plan allows you to choose the executor of your Estate and guides your family with your written wishes

Allows you to designate a preferred guardian of you and your minor children should the need arise

Lowest cost option

The downside to this plan is that minor children and beneficiaries receive their entire inheritance at age 18, the Estate is generally subject to probate which can cost up to 5% of the value of your Estate, and funds for minor children are held in a court-blocked account until they reach age 18

Total cost: \$49 per person

Revocable Living Trust



This plan is similar to the other options, but allows you to avoid probate and the significant associated costs

Includes a Pourover Will, Power of Attorney for Financial Decisions, Health Care Power of Attorney, Revocable Living Trust, Certificate of Trust, and a Deed for your real property in Nevada (up to 3 included)

This plan allows the transfer of assets to heirs without going through the costs of probate

Allows flexibility and timing for distributions to minor or special beneficiaries

This plan is higher cost, but beneficial to first responders, who face higher risk of dying while on duty during their working years, potentially leaving minor children as heirs

Total cost: \$995 Single or Married (not per person)
